**VOLUNTARY ANNOUNCEMENT  
CHINASOFT ENTERS INTO INDUSTRY 4.0  
COOPERATION AGREEMENT WITH HUAWEI  
LEADING THE TRANSFORMATION OF  
TRADITIONAL MANUFACTURING INDUSTRY TO INTERNET+**

This announcement is issued by Chinasoft International Limited (“**Chinasoft**” or the “**Company**”) as a voluntary announcement to allow the public to understand the latest information on the Company.

The Company announced that it has entered into a strategic cooperation agreement with Huawei Technologies Co. Ltd. (“**Huawei**”) and Wuhan Fenjin Tech Co. Ltd.\*(**武漢奮進技術有限公司**)(“**Wuhan Fenjin**”) on Industry 4.0. The three parties will together provide collaborative solutions to industry vertical and enterprise customers in Industry 4.0, and together drive the construction of industrialization ecosystem and implementation of Industry 4.0 by introducing smart production and helping traditional manufacturing enterprises to transition through the Internet+.

Pursuant to the cooperation agreement, Huawei will provide agile Internet of Things (IoT) solutions, Chinasoft will focus on the integration of smart application, and Wuhan Fenjin will offer base layer sensors and robotic technologies. The three parties will jointly provide its manufacturing clients with competitive solutions, products and services in Industry 4.0, in areas of planning, designing, testing and marketing. The parties will complement each other’s strengths and set examples of vibrant Internet of Things ecosystems for the coming digitalization of the manufacturing industry.

## **THE COMPANY INTRODUCED CONCEPT AND FRAMEWORK OF SDN SOFTWARE DEFINED FACTORY**

At the HuaweiCloud 2015 (HNC2015) held a few days ago, Chinasoft, Huawei and Wuhan Fenjin jointly announced its smart solutions and provided demonstrations.
